# **Answer the following:**

1. Use the terms 'constituency' and 'represent' to explain who an MLA is and how is the person

Answer- MLA is the member of the legislative assembly who represents people and also part of the government.

- (i) Each state has a legislative assembly.
- (ii) A state is divided into different areas or constituencies.
- (iii) From each constituency, the people elect one representative who then becomes a Member of the Legislative Assembly (MLA).

### 2. How did some MLAs become Ministers? Explain.

Answer (i) After the elections, a political party whose MLAs have won with more than half the number of constituencies in a state became the ruling party.

- (ii) The MLAs belonging to the ruling party will elect their leader who will become the chief minister.
- (iii) The chief minister then selects other MLAs from his party as ministers.
- (iv) The Governor of the state then appoints the chief minister and other ministers.

# 3. Why should decisions taken by the Chief Minister and other ministers be debated in the Legislative Assembly?

#### Answer

- The decisions taken by the Chief Minister and other ministers need approval from the Legislative assembly as these decisions are taken in interest of people at large number.
- Democracy has permitted the other members of the house to ask a question, decide where the money should be spent, and debate on the more important issue. It looks into the matter whether a particular decision is in the interest of the people or not.
- The MLAs selected as Ministers are collectively responsible to the Legislature for their decisions. This enhances the accountability, transparency, and representativeness of the Cabinet.

Answer: There was a lack of proper sanitation and clean drinking water in Patalpuram. It resulted in the death of people due to the water-borne diseases that are spreading from filth. The shortage of proper medical facilities has made the condition worse.
